



MEDLINE VIA OVID OR VIA PUBMED?

Medline is the leading biomedical literature database, comprising over 26 million citations from over 5600 peer-reviewed journals going back to 1946. Users have been able to search Medline via PubMed, the free search interface developed by the National Library of Medicine (NLM), since 1996. Medline is also available on other platforms, including Ovid.

MUHC libraries users have access to Medline via Ovid or via PubMed.

While the differences between both platforms in terms of content are minor, each interface is unique and has its own drawbacks and merits.

Other Medline characteristics such as update frequency, or managing searches or results are similar between both interfaces.

When should you choose Medline via PubMed?

- When you are outside the MUHC.
- When you need to quickly find a few articles.

When should you choose Medline via Ovid?

- When you need to use advanced search operators to design a precise and/or sensitive search strategy.

Tips on designing an exhaustive search:

Approximately 11% of articles in Medline are not yet indexed with Medical Subject Headings (MeSH). Therefore, in addition to the usual search with MeSH, you must supplement your strategy by searching for words in the titles and/or abstracts to retrieve articles that are not yet indexed.

For example, to retrieve all articles in a search on Multiple Sclerosis:

Note also that other databases are available via Ovid: Embase, PsycINFO, etc. (Ovid full list of databases: <http://ovidsp.ovid.com/autologin.html>). The time invested in becoming more familiar with Ovid's search interface will allow you to diversify your information resources.
